### RPA DEADLINE PASSED - TIME TO DRAW BREATH AND REFLECT



# Rural Payments Agency

With the passing of the 15th May we can draw breath and reflect on a year where many claims were relatively straight forward, but a significant number were caught up in either historic errors, inspection delays or ongoing RPA system issues, which continue to cause uncertainty, worry and excessive time in their completion. Despite BIAC's continuing efforts to instil better accountability at the RPA, there is a sense that the

current system is simply going to rumble forward for a couple more years with minimal investment and improvement until longer term political decisions are made...

Advisors should be aware that they can make certain changes to submitted applications without penalty before midnight on 31st May and changes with penalties until 9th June. Details of this process have been circulated to BIAC members and appear on the Gov.uk website.

Historic issues (from 2015 and 2016) remain the biggest concern to many. The RPA have at last started working

through the reconciliation list and steady progress is being made with payment recalculations. BIAC will continue to put pressure on the RPA to resolve these issues.

On a separate note, Natural England have just about succeeded getting 2017 stewardship offers out before the 15th May. In recognition of the delays, the claim deadline for Agreements starting 1st January 2017 has been extended to 15th June. The practical impacts of these delays have been significant and many claimants may not receive the full stewardship payment in the first year.
